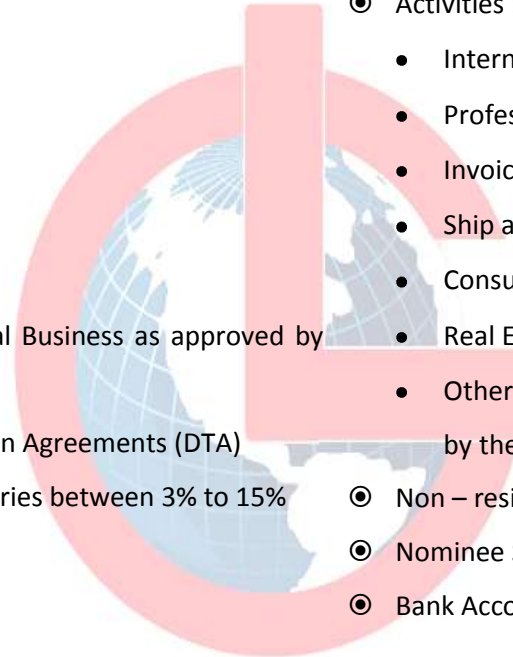
COMPANIES INCORPORATION CARRY OUT BUSINESS WORLDWIDE

Category 1 Global Business Companies (GBC1)

- ⊙ Licensed by the FSC
- ⊙ Activities:
 - Consultancy
 - Asset Management
- ⊙ Financial Services
 - Insurance
 - Trading
 - Funds Management
 - Any other qualified Global Business as approved by the FSC
- ⊙ Benefits of the Double Taxation Agreements (DTA)
- ⊙ Taxation on foreign income varies between 3% to 15%
- ⊙ Capital gains are exempted

Category 2 Global Business Companies (GBC2)

- ⊙ Regulated by the FSC under the Financial Services Act 2007
- ⊙ Activities :
 - International Trading
 - Professional services rendered
 - Invoicing
 - Ship and ship management
 - Consulting services
 - Real Estate
 - Other qualified Global Business as may be approved by the FSC
- ⊙ Non – resident for tax purposes in Mauritius
- ⊙ Nominee Shareholder and Corporate Director
- ⊙ Bank Accounts worldwide



Additional Services

Treasury

- ⊙ Provision of local signatories
- ⊙ Facilitator for guarantees and letter of credit with banks
- ⊙ Established relationship with local and foreign banks for Forex transactions

Protected Cell Company (PCC)

- ⊙ Qualifies for a GBC1 licence
- ⊙ Special Purpose Vehicle providing legal segregation of assets attributable to each cell of the Company either individually or corporately owned
- ⊙ Segregate risks in different cells
- ⊙ Activities:
 - Investment funds
 - Asset Management
 - Insurance

TRUSTS ENHANCE AND SAFEGUARD ASSETS FOR THE BENEFIT OF BENEFICIARIES

Trusts

- ⊙ Resident and non-resident trusts
- ⊙ Duration of Trust is 99 years
- ⊙ Registration of a trust is not required with authorities
- ⊙ No need to file accounts or annual returns
- ⊙ Possibility of avoiding forced heirship rules
- ⊙ Foreign trust may be registered in Mauritius

Private Trust Company (PTC)

- ⊙ Managed by a licensed Trust Company
- ⊙ Act as a Trustee to a limited number of Trusts
- ⊙ A PTC cannot act as trustee by way of business, i.e., to the public in general
